






Total number of included discharges vs total number of excluded discharges










Percent of discharges by type of payor


Percent of discharges by specific age group


Percent of discharges by Primary Medical Condition groups




Percent of discharges by specific clinical program




Percent of discharges that received therapy


Percent of discharges that received therapy by type of therapy






Mobility Improvement by Primary Medical Condition (Without Exclusions)








Percentage of Goals Met




Percent of all discharges by disposition




